1 AND NOW, this matter having come before this Court on Plaintiffs' Motion for Award  
2 of Attorney's Fees and Expenses and in Support of Service Award and Individual Settlement  
3 (Doc. 74), and following a hearing held on October 21, 2021, and for the reasons stated on the  
4 record, the Court finds that:

5 1. Plaintiff's counsel shall be awarded \$263,000.00 in attorney's fees and an  
6 additional \$15,683.89 in litigation expenses for a total of \$278,683.89, to be paid by Defendant  
7 pursuant to the parties' Settlement Agreement.

8 2. The additional \$13,316.11 in fees sought by Plaintiff's counsel and not approved  
9 by this Court shall be added to the Net Settlement Amount and distributed to class members *pro*  
10 *rata* under the parties' Settlement Agreement.

11 3. The \$10,000.00 individual settlement and service award sought for Plaintiff David  
12 Watson is approved in full and shall be paid by Defendant pursuant to the parties' Settlement  
13 Agreement.

14 4. A post-settlement distribution status conference shall be held on **April 19, 2022**  
15 **at 2:30 pm** with status report due 4/12/2022.
